Regular Monthly Meeting
April 16th, 2024

Sigel Township Hall, 5784 Sand Beach Rd, Harbor Beach, MI 48441

Meeting called to order by Supervisor Maurer at 8:00 pm. Board members present: Maurer, Bischer, Essenmacher, Sweeney and Grekowicz. Also in attendance were Fire Fighters Joel Kiehl and Jason Lermont, resident Lauren Lackowski and Garren Griffith from First Land Services.

Minutes were approved from the March 18th, 2024, Meeting. Motion Essenmacher, second Grekowicz to approve minutes. Motion Carried 5-0.

Treasurer Report: General Fund starting balance \$912,781.37. Income of \$2,037.37 and Expenses of \$53,506.29 for an ending balance of \$862,290.16. Fire Fund starting balance \$452,066.02. Income of \$206.69 and Expenses of \$7,824.39 for an ending balance of \$444,448.32. Road Fund starting balance \$403,090.84. Income of \$310.92 for an ending balance of \$403,401.86. Total of all three ending balances of \$1,710,140.34. Motion Bischer, second Sweeney to approve all 3 treasurer reports. Motion Carried 5-0.

Motion Bischer, second Grekowicz to pay months bills in the following amounts. General Fund \$53,506.29 checks 1156-1207. Fire Fund \$7,824.39 checks 1877-1882. Road Fund \$0.00. Motion Carried 5-0.

Motion Grekowicz, second Sweeney to approve 1.5 miles of gravel on Finkle Rd, gravel on Ulfig Rd west of Parisville Rd and Duda Rd west of Parisville Rd at an estimated cost of \$100,000. Motion Carried 5-0.

Clerk Bischer reminded the board of the upcoming Road Commission meeting.

Clerk Bischer reported that all paperwork has been submitted to the Clerk's office to place the Road Millage Renewal on the August ballot.

Clerk Bischer reported on the progress for the Township Website. It has been difficult to register for a .gov domain.

Clerk Bischer reported submitting the ARPA report that is due April 30th.

Joel Kiehl reported that the Central Huron Ambulance is continuing its efforts for a special assessment.

Firefighters reported on activities in the township and that there were 101 kids for Rural Schools Fire Safety.

During Public Comment, Garren Griffith talked about the new state sitting of energy developments and how it affects energy development going forward. Local control of green energy projects has been removed and handed over to the State.

Motion Bischer, second Grekowicz to adjourn meeting. Motion Carried 5-0. Meeting Adjourned at 8:49pm.
