Regular Monthly Meeting
February 20th, 2023

Sigel Township Hall, 5784 Sand Beach Rd, Harbor Beach, MI 48441

Meeting called to order by Supervisor Maurer at 5:00 pm. Board members present: Maurer, Bischer, Essenmacher, Sweeney and Grekowicz. Also in attendance were Dan Glaza and Firefighters Joel Kiehl, Rusty Lemanski, and Jason Lermont.

Minutes were approved from the January 16th, 2023 Meeting. Motion Essenmacher, second Grekowicz to approve minutes. Motion Carried 5-0.

Treasurer Report: General Fund starting balance \$470,250.58. Income of \$89,700.89 and Expenses of \$11,967.68 for an ending balance of \$547,983.79. Fire Fund starting balance \$343,1117.65. Income of \$45,729.73 and Expenses of \$4,747.94 for an ending balance of \$384,099.44. Road Fund starting balance \$420,100.88. Income of \$91,317.24 and Expenses of 0.00 for an ending balance of \$511,418.12. Total of all three ending balances of \$1,443,501.35. Motion Sweeney, second Essenmacher to approve all 3 treasurer reports. Motion Carried 5-0.

Motion Grekowicz, second Essenmacher to pay months bills in the following amounts. General Fund \$6,001.28 checks 6914 and 1006-1012. Fire Fund \$4,747.94 checks 1777-1785. Road Fund \$0.00. Motion Carried 5-0.

Supervisor Maurer reported on the bid to prepare Minden Rd approximately 1 mile north of M-142 for paving. No action was taken. Supervisor Maurer will seek a bid to prepare Minden Rd for paving from M-142 to Learman Rd.

Joel Kiehl reported on the monthly Central Huron Ambulance meeting.

Approval of the agreement with Central Huron Ambulance was tabled until the March monthly meeting.

The Settlement and Budget Meeting was set for March 20th, 2023 immediately following the regular monthly meeting.

The Annual Meeting was scheduled for March 25th, 2023 at 1:00pm at the Township Hall.

Clerk Bischer reported on the Uby Community School May election. Sigel Township is responsible for all activities related to absentee voting with the election being held by Bingham Township.

Clerk Bischer reported on the requirement of an Absentee Voter Drop Box.

Firefighters reported on activity in the township.

During Public Comment Dan Glaza announced and upcoming Connect America meeting being held at the Huron County Senior Center on March 14th at 5:30pm. He also commented on the upcoming Satellite Pace Center at the Huron County Senior Center.
