

**Sigel Township**  
**Regular Monthly Meeting**  
**April 18<sup>th</sup>, 2022**

Meeting called to order by Supervisor Maurer at 8:00pm. All board members present. Also in attendance were Fire Chief Joel Kiehl, County Commissioner Mary Babcock and Assessor Wade Mazure.

Minutes were approved from the March 21<sup>st</sup>, 2022 Meeting. Motion Grekowicz, second Essenmacher to approve minutes. Motion Carried 5-0.

Treasurer Report: General Fund starting balance \$624,105.97. Income of \$5.24 and Expenses of \$26,111.30 for an ending balance of \$597,999.91. Fire Fund starting balance \$387,408.14. Income of \$26.23 and Expenses of \$16,655.93 for an ending balance of \$370,778.44. Road Fund starting balance \$556,570.99. Income of \$32.28 and Expenses of \$7.00 for an ending balance of \$556,596.27. Total of all three ending balances of \$1,525,374.62. Motion Essenmacher, second Sweeney to approve all 3 treasurer reports. Motion Carried 5-0.

Motion Bischer, second Essenmacher to pay months bills in the following amounts. General Fund \$26,111.30 checks 6802-6831. Fire Fund \$16,655.93 checks 1694-1723. Road Fund \$7.00, service charge. Motion Carried 5-0.

Motion Essenmacher, second Grekowicz to dispense with reading of Resolution 2022-4-1, Satisfaction Agreement regarding DTE Wind Park. Motion carried.

Motion Grekowicz, second Sweeney to adopt Resolution 2022-4-1, Satisfaction Agreement regarding DTE Wind Park. Bischer, Grekowicz, Essenmacher, Sweeney and Maurer voted Aye. Motion Carried.

Motion Grekowicz, second Essenmacher to pave .85 miles of McKichen Rd at an estimated cost of \$160,629.25, with all awarded ARPA funds, \$45,608.50, being budgeted to the project. Motion carried 5-0.

Clerk Bischer and Trustee Sweeney Reported on the 2022 Huron County Road Commission Annual Meeting.

Motion Bischer, second Grekowicz to set Board of Review wages at \$60 for ½ day and \$120 for a full day. Motion carried 5-0.

Fire Chief Joel Kiehl reported on activities in the township.

Motion Grekowicz, second Essenmacher to adjourn meeting. Motion Carried 5-0. Meeting Adjourned at 8:52pm.
