Regular Monthly Meeting
May 16th, 2022

Sigel Township Hall, 5784 Sand Beach Rd, Harbor Beach, MI 48441

Meeting called to order by Supervisor Maurer at 8:03pm. All board members present. Also in attendance were Firefighters Joel Kiehl, Rusty Lemanski and Jason Lermont. Also present was John Koets.

Minutes were approved from the April 18th, 2022 Meeting. Motion Grekowicz, second Essenmacher to approve minutes. Motion Carried 5-0.

Treasurer Report: General Fund starting balance \$597,999.91. Income of \$9,481.19 and Expenses of \$6,608.07 for an ending balance of \$600,873.03. Fire Fund starting balance \$370,778.44. Income of \$4,065.81 and Expenses of \$11,096.41 for an ending balance of \$363,747.84. Road Fund starting balance \$556,596.27. Income of \$4915.72 and Expenses of \$7.00 for an ending balance of \$561,504.99. Total of all three ending balances of \$1,526,125.86. Motion Bischer, second Sweeney to approve all 3 treasurer reports. Motion Carried 5-0.

Motion Essenmacher, second Grekowicz to pay months bills in the following amounts. General Fund \$6,608.07 checks 6832-6837. Fire Fund \$11,096.41 checks 1724-1730. Road Fund \$7.00, service charge. Motion Carried 5-0.

John Koets of the Ted Hartleb Agency presented on the current township insurance coverage.

Motion Essenmacher, second Grekowicz to pay Huron County Road Commission \$129,283.95 for asphaltting .85 miles of McKichen Rd using ARPA funds and township funds. Motion Carried 5-0.

Supervisor Maurer reported on roads projects. The following roads will receive gravel in 2022: Rapson Rd from Verona Rd to McKichen Rd, Rapson Rd from Parisville Rd to Finkle Rd, Finkle Rd from M-142 to Learman Rd, and Kipper Rd from McKichen Rd to Johnston Rd. Brush spraying, crack sealing and gravel patching will also occur as needed.

Upcoming brining of roads was discussed. Supervisor Maurer has been in contact with Rooney Construction.

Clerk Bischer reported that all 17 townships approved the settlement with DTE regarding wind turbines.

Clerk Bischer reported that the PA 116 Annual Report will no longer be mailed and is now available online.

Firefighters reported on activities in the township.

Motion Grekowicz, second Essenmacher to adjourn meeting. Motion Carried 5-0. Meeting Adjourned at 9:48pm.
