Regular Monthly Meeting
August 19th, 2024

Sigel Township Hall, 5784 Sand Beach Rd, Harbor Beach, MI 48441

Meeting called to order by Supervisor Maurer at 8:01 pm. Board members present: Maurer, Bischer, Essenmacher, Sweeney and Grekowicz. Also in attendance were Joel Kiehl, Sandy Guza, Lauren Lackowski and Clint Balcer.

Minutes were approved from the July 15th, 2024, Meeting. Motion Essenmacher, second Grekowicz to approve minutes. Motion Carried 5-0.

Treasurer Report: General Fund starting balance \$926,811.05. Income of \$4,337.51 and Expenses of \$6,741.51 for an ending balance of \$924,407.05. Fire Fund starting balance \$429,689.22. Income of \$196.10 and Expenses of \$3,138.14 for an ending balance of \$426,747.18. Road Fund starting balance \$57,762.63. Income of \$45.81 and Expenses of \$23,408.00 for an ending balance of \$34,400.44. Total of all three ending balances of \$1,385,554.67. Motion Bischer, second Sweeney to approve all 3 treasurer reports. Motion Carried 5-0.

Motion Bischer, second Grekowicz to pay months bills in the following amounts. General Fund \$6,741.51 checks 1237-1243. Fire Fund \$3,138.14 checks 1899-1903. Road Fund \$23,408.00 check 1070. Motion Carried 5-0.

Supervisor Maurer reported that Kipper Rd west of Parisville Rd had maintenance and gravel applied to address water issues.

Motion Bischer second Grekowicz to gravel Learman Rd from Parisville Rd to Johnson Rd and Duda Rd from Finkle to Minden Rd. Motion Carried 5-0.

Clerk Bischer reported that the Township website went live on August 6th and it can be viewed at sigeltownshipmi.gov.

Motion Grekowicz second Bischer to submit the L-4029 form with full millage levels. Motion carried 5-0.

Treasurer Grekowicz will complete the audit agreement with Brining and Brining and send the completed copy to their office.

Clerk Bischer reported on the August Primary election. There was a total of 150 ballots cast. Of those 5 voted early at Harbor Beach City Hall. There were 43 absentee ballots returned and processed on Election Day additionally there were 102 voters on Election Day.

Clerk Bischer reported the Township Road Millage passed by a vote of 104 yes to 27 no. Clint Balcer and Joel Kiehl were elected to Trustee positions. Lauren Lackowski was elected to the Clerk position and Dennis Bischer was elected Supervisor.

Joel Kiehl reported on Central Huron Ambulance.

Fire Chief Joel Kiehl reported on fire activities in the Township and that they are looking for a new training officer.

Motion Bischer, second Grekowicz to adjourn meeting. Motion Carried 5-0. Meeting Adjourned at 8:44pm.
